

TERMS AND CONDITIONS

Please read all the terms and conditions ("Terms") carefully. Each individual who registers to participate in "Look Your Best. Be Your Best." ("the Contest") (and, where applicable, in the case of a participant below the age of 18 years, the participant's parent, guardian or legal representative) ("Participant") declares and acknowledges to have read, understood and agreed to the Terms below and undertakes to comply with and be bound by the same.

The contest is organized by BUBBLE GUM X SDN BHD and will be held from 01 August 2022 to 31 October 2022.

1. Eligibility

- a. The contest is open to all Malaysians age 13 and above, and new or existing customers for BUBBLE GUM WAX, BUBBLE GUM LASH, BUBBLE GUM NAILS and BUBBLE GUM XTHETIC.

- c. BUBBLE GUM X SDN BHD reserves the right at its sole and absolute discretion to suspend or extend the submission period for any reason at any time and without any liability. Any change in dates will be communicated through Facebook, Instagram and the Bubble Gum X website.
- d. Participants who provide incomplete details, fail to provide a TikTok/Instagram Reel video, or provide duplicated TikTok/Instagram Reel video, will be automatically disqualified from participation.
- e. BUBBLE GUM X SDN BHD reserves the right at its sole and absolute discretion to reject any entry if it is incomplete, illegible, falsified, irregular in any way or otherwise not in compliance with these terms and conditions.
